New Business

Comments on filter proceed with many comments about the function of the filter or the type of limestone used. Steve see's that a lot of water is going over the top in large waterfall with lots of water not going through the filter and just passing over the top. Gene K believes a mistake was made in the type of limestone is not correct. He thinks we may need to replace the fill limestone? He wants to test the fill to make sure it's the right fill. He

feels it's time for more dialog. Need to figure out the dept of the water going over the filter and how wide the water flow. Gene M suggests we take pictures of times when it flows over the top.

Monthly testing (Tom) and Tom will continue to do this monthly test. He offers to take anyone along with him to see how it's done.

August meeting details. Not sure how to plan meeting to keep everyone safe. Perhaps we can video tape and provide to public. Need suggestions on how to do this meeting. Steve has tentative meeting set for Aug 1st. Steve asked for a credit and to give us a free meeting in Aug but it was declined. They said they would keep money and put towards the Aug meeting. Gene K thinks since the state fair is canceled that we should also cancel. Last Aug we had 30 plus participants, so we need to think about the Aug meeting as Zoom meeting. Gene is concerned that he has concerns and doesn't think we should have a Aug meeting. Kathleen also agrees. Most agree that the Aug meeting won't happen. How will we continue to have regular meetings? Zoom? Rent township hall? Steve offers a covered carport to have a meeting. Doug wants to make sure that the bay spraying and channels is for boat travel and individuals are responsible to spray their own shoreline. Kathleen stated she continues to spray their own shoreline. Everyone agrees that the LID suggests that homeowners should do their own shoreline spraying.
